MILLIGAN reported that the Faculty of Humanities, Associate Dean Academic Search Committee has put forward a name for ratification.

# 5. REPORTS

# A. MEMBERSHIP REPORT

GSS Membership: As of April 8, 2022 there are 3097 GSS Members.

**GRC Membership:** GRC now consists of 29 academic units (out of 46 academic units eligible), and 5 Executive Board members.

**Meeting Quorum:** With 3 regrets received, quorum for tonight's meeting is 16. As of 5:10 pm, the meeting was not quorate.

# B. CHAIR'S REMARKS

OKIBE introduced herself as the new GSS Chair for 2022-23 and expressed hope for working together for common goals. BICKLEY as the new Director of Finance expressed hope to building a strong Finance Committee. MADDOX, the new Director Services, expressed enthusiasm for building community and cohesion amongst graduate students. SAFARI, re-elected as Director of Student Affairs, spoke about hoping to build on the past year's advocacy work of the Student Affairs Committee and hopes for continuing to improve. KENT, re-elected as Director of Communications, was not present.

# C. EXECUTIVE BOARD REPORTS – QUESTIONS ARISING AND MOTION TO ACCEPT

MOTION: BIRT the Executive Board reports for January are approved, as recommended by the Stipend Review Committee.

MOTION: BIFRT that the overview portion of the Director of Finance June 2021 – June 2022 monthly reports are redacted by the Stipend Review Committee.

FRANCIS spoke to the motions on behalf of the Stipend Review Committee.

Motion was tabled due to lack of quorum.

#### D. ACADEMIC UNIT & COUNCILLOR REPORTS - ROUND TABLE

Members had a chance to informally report on issues facing members in their departments and general issues pertaining to graduate students at UVic for the summer semester and the re-opening of on-campus studies.

In general, issues raised in the discussion included:

- Some department confusion about unit allocation for courses not meeting minimum units required to apply for grants and student loans.
- New grad students can be surprised by the requirement to stay enrolled over summer.
- Housing continues to be a struggle. It was noted as particularly difficult for Music students who need space to practice.
- Funding continues to be a major concern. English has decided not to accept any new graduate students this year in hopes of ensuring current students can be supported.
- Concerns that as UVic goes back to focusing on on-campus, the distance students will become invisible again for UVic, but also for access to participation in the GSS and student governance (it was noted that the HSD Faculty has at least 6 distance Masters programs and 1 distance Phd).
- As well, graduate students in professional programs who work on a different schedule are most often excluded from opportunities to participate and be engaged.
- GRC reps noted how difficult it has been to find ways to connect with distance members.
- DERRICK noted that Public Health has an issue a 450 hour practicum that is required, that is unpaid, at the same time as paying full time tuition fees.

Members wanting their full report noted in the minutes were asked to submit their report in writing.

This is an important committee that influences the quality of the degrees provided by UVic provides. Currently concluding work to change requirements for sick notes. There is ongoing work on the Academic Integrity Policy. The Academic Accommodations Policy may be upcoming this year. The Committee has a good culture, is respective of student opinions and for anyone interested in academia, this is a great experience.

It was asked if people could participate on UVic committees via Zoom. POTTS explained that anytime a UVic person requests a grad student rep, they are prompted that 1/3 of our members are distance students and they are asked if arrangements support a graduate student participate remotely.

# MEETING NEW BUSINESS

TURNER explained that in the absence of quorum, discussion of the meeting new business items will proceed, but recommended an email vote on the COVID safety regulations, and that the motions to adopt the policy revisions will be tabled to the June GRC meeting.

# COVID-19 SAFETY REGULATIONS FOR GSS EVENTS AND HALPERN CENTRE

REF DOC: <u>BC COVID-19 Restrictions</u> Lead: Kyla TURNER, Executive Director

Purpose: for decision

Motion: BIRT to rescind the July 20, 2021 motion:

"RESOLVED "in-person event" is defined as an organized event that involves Society members interacting in the same physical space and is not necessary for the continued functioning of the Society.

"FURTHER RESOLVED "in-person event" does not include in-person services offered to Society members on an individual basis.

"FURTHER RESOLVED "outdoor event" is defined as an in-person event that takes place in an open space without vertical walls or partitions and which may include an awning or canopy.

"FURTHER RESOLVED "indoor event" is defined an as in-person event that takes place in a space with one or more vertical walls or partitions.

"FURTHER RESOLVED all persons entering the Halpern Centre shall be required to wear non-medical face coverings

"FURTHER RESOLVED the Society may hold or sponsor outdoor events provided that social distancing is maintained outside of each participant's chosen personal contacts.

"FURTHER RESOLVED the Society may hold or sponsor in-person indoor events provided that the requirements for indoor events specified by the BC Provincial Health Officer's order regarding gatherings and events dated July 7, 2021, until such time as this motion is revoked, and that all participants are required to wear non-medical face coverings "FURTHER RESOLVED no meetings of Society members (including Executive Board meetings, GRC meetings, general meetings, committees and working groups) shall be held in-person.

"FURTHER RESOLVED Society Board members or volunteers may choose to attend and represent the Society at in-person events and meetings held by the University, however the Society does not endorse such events and meetings and will not accept liability for any damages caused by holding such events and meetings.

"FURTHER RESOLVED the Society recognizes that its jurisdiction is limited to the Province of B.C., however, Executive Board Members, Grad Council members and volunteers located outside the Province of B.C. are expected to adhere to the legislation and public health orders of the jurisdiction in which they are located."

BIFRT that the GSS will observe all in-force COVID-19 restrictions as set by the Public Health Officer of British Columbia.

BIFRT that the GSS shall post signage stating that symptomatic individuals will not be granted entry into Halpern Centre.

BIFRT that masks will be strongly encouraged within Halpern Centre and during any indoor GSS events or GSS-sponsored events until September 6, 2022 unless required by the Public Health Officer of British Columbia.

TURNER presented background on the motion. TURNER explained that the Executive Board wanted to create a motion that was as permissive as possible, allowing staff to react to emergent safety protocols as needed. The motion allows for in-person and hybrid meetings.

FOSTER argued that the original motion should be upheld until the end of summer 2022. FOSTER disagreed that the original motion disallowed in person meetings or events. It was just specific about the standards, e.g. no food or drink. FOSTER argued that the main reason he is against the motion is the argument outlined by the BC Human Rights Commissioner in March 2022 that removing the mask mandate is an issue of diversity and inclusion. The Human Rights Commissioner argued that removing the mask mandate puts the onus on disabled and marginalized students to put more restrictions on themselves because the able-bodied have had their restrictions lifted. The Commissioner stated that a masks-optional policy further isolates the vulnerable and limits their access. <a href="https://bchumanrights.ca/wp-content/uploads/2022.03.16-Letter-to-Bonnie-Henry-End-of-Mask-Mandate.pdf">https://bchumanrights.ca/wp-content/uploads/2022.03.16-Letter-to-Bonnie-Henry-End-of-Mask-Mandate.pdf</a> FOSTER argued that the GSS having higher standards than UVic makes a positive statement about caring about inclusion and vulnerable people.

MADDOX argued that this motion was brought forward in consultation with GSS staff who would have to enforce restrictions that are not in place anywhere else on campus as GSS does not have a building security person. MADDOX also argued that the original motion references a public health order no longer in effect, and that the specificity of the original motion is also outdated.

BICKLEY suggested that for the current time, with the high rate of transmission in place, he supports FOSTER's opinion to continue with current practices, but supports in future, moving these decisions to the operational level so that the GSS can state up to date.

FRANCIS suggested that it would be good to have more discussion from more GRC reps.

TURNER asked for a straw poll to vote either in favour of taking this motion to an email vote, or, to vote no and table the motion to the next GRC meeting. From the poll, members were in favour of tabling the motion and having more discussion at the next GRC meeting on June 21st. Members were not in favour of having an email vote.

Motion TABLED due to meeting not achieving quorum.

# APPENDIX A: UVIC COMMITTEE GRAD REP REPORTS

# Senate Report April 2022 – David Foster, Graduate Student Senator

- On March 10, 2022, the UVic administration chose to lift UVic's mask requirement the same day the
  provincial mask mandate lifted, without adequate consultation, in particular with faculty and staff
  with disabilities who are most affected
- A group of senators called a special meeting by petition in order to consider a motion recommending that the UVic President and Board of Governors reinstate the mask mandate until the end of the spring semester
- Unlike UVic, UBC decided to keep the mask mandate until the end of April
- The special Senate meeting was held on March 24, 2022, in a room that did not allow many participants to be socially distanced, and without a mask requirement a questionable decision given that a number of senators had expressed concerns about the safety of non-socially distanced, non-masked indoor gatherings
- At the special meeting, senators voted 23 to 19 to recommend that the mask mandate be reinstated
- Faculty members have expressed significant concerns about the safety of classrooms as workplaces where students are crammed together without social distancing or masks
- On March 24, shortly before the special meeting, a UVic executive staff member sent an inappropriate email to all Senators ordering us not to discuss items on the Senate agenda outside of a Senate meeting
- The email interfered with the rights and privileges of elected Senators, who have the right to discuss any business before Senate with each other at any time, and further have the right to discuss any public matter before Senate with whomever they wish at any time via any medium
- At the April 1 Senate meeting, I raised a point of personal privilege to the Chair of Senate, Dr. Kevin Hall regarding this inappropriate email, but Dr. Hall has not acknowledged the issue
- I am submitting a motion to the May Senate meeting to censure Dr. Hall in his capacity as Chair of Senate for his role in infringing the rights of Senators, including his unreasonable refusal to allow an elected Convocation senator to attend Senate meetings remotely
- Some senators have been allowed to attend remotely due to personal health issues or being outside Canada, but one senator's request for remote attendance in order to protect medically vulnerable close contacts was denied
- Dr. Hall's decision is contrary to the *University Act* and relies on an unreasonably narrow interpretation of the *Senate Rules and Procedures*
- As a result of Dr. Hall's unfair actions, an elected Senator has not been allowed to attend the October, November, December, February, March regular and special, or April Senate meetings
- Dr. Hall has also not provided adequate reasons for his decision which set out his legal justification, or provided information on how the senator can challenge the decision, which amount to violations of procedural fairness
- A motion of censure is symbolic and would have no effect other than Senate distancing itself from Dr. Hall's conduct, however it is important for Senate to do this as Dr. Hall's conduct reflects badly on the University
- The May 6 Senate meeting is also expected to include the revised policy on students with disabilities
  and a revision to the Senate rules regarding remote attendance which could clarify the rules going
  forward, but may not reflect what students have requested

# Board of Governors Report April 2022 - David Foster, Graduate Student Board Member

- The Board of Governors met on March 28 and 29
- At the March 28 meeting, the Board voted not to accept the Senate recommendation to reinstate
  the mask requirement; this decision was made in-camera so I cannot provide further information
  beyond what was released by the University
- In general, however, my observation of the UVic administration indicates that they do not appear to
  value the lives of people with disabilities and chronic health conditions as much as returning to the
  appearance of normality, and do not take the genuine concerns of faculty members about workplace
  safety seriously
- On March 29, the Board passed the University's annual budget, which includes a 2% tuition increase
  for domestic students, 3.75% tuition increase for international undergraduate students but only 2%
  tuition increase for international graduate students, along with 5% increases to residence rent and
  meal plans
- 2022 is the final year of a three-year period where the University committed to maintaining the same rate of international tuition increase year to year (3.75% for undergraduate students and 2% for graduate students) so we may see significant international tuition increases next year
- I abstained on the budget vote, as I felt it was necessary for the University to pass a budget but had significant concerns about continuing to increase international tuition as well as the 5% residence rent increase
- Tenants in off-campus housing have their rent controlled by provincial legislation which only allows a 1.5% increase within a year under the same tenancy, but on-campus housing has no rent controls; with the lack of off-campus housing students do not have a lot of options
