## 1. WELCOME TO GRC! 5:50

MADDOX provided a brief overview of the work of GRC, the vital role our representatives play in keeping the GSS working for our memberships and welcomed everyone to a new term.

TURNER asked after providing separate GRC member training as the election of an Interim D. Services ate through the time we'd otherwise spend on training. GRC members chose to conduct training at Wednesday coffee in October.

## 2. WELCOME TO GRADUATE STUDIES FROM HICKS! 5:55

Lead: HICKS Reference: For: Discussion HICKS welcomes all our new reps to UVic and discussed the ways in which student leadership shapes our campus and drives advocacy both on- and off-campus. HICKS provided a chart of the graduate students, and the faculties are arranged by the institution. Further HICKS said faculty of graduate studies work on cultivating and proposing policies. HICKS said about admission is the record keeping of the graduate student's time in school.

Currently HICKS is working on career preparation: motivated by couple thing from federal and provincial government is under funding. HICKS said why the federal government wants to invest into graduate students. HICKS and his office are preparing for finding solutions and asking departments to put some efforts in students their department when they graduate. 1. Professional development or co-curricular 2. professional training.

HICKS discussed FGS has taken actions to acquire this type of training module should be involved for student learning. HICKS mentioned that FGS is supporting supervisor and emphasis on experiential learning

HICKS on equity review which is campus wide and number of action items and one of them is review/update of UVic graduate supervision policy.

#### 3. WHAT'S GOING ON WITH FUNDING WITH HICKS 6:05

Lead: HICKS Reference: For: Discussion

HICKS mentioned the source of funding and emphasises the magnitude of problem is huge. HE mentioned the money from institution spending of funding graph in his ppt. Majority of which is for RA, TA and federal award and FGS.

HICKS said funding issue will take some time and external advocacy is crucial for raising this concern. House of commons have a committee which has been working on the student funding said by HICKS.

Further HICKS said his work is to make sure the funding must be transparent and have the capacity to parameterized and shared with graduate students. FGS cannot individually interfere in the departmental funding policies.

Iman's question was about budget cuts and students have been in difficult position with work and living cost in Victoria. Iman asked from HICKS opinions what type of efforts or actions would be effective in raising this concern? HICKS answer was on national level like national award funding over the past years have stagnate and 4% of only graduate students get these awards and federal governments action must in funding towards research grants because that's majority of money coming from. HICKS further said he and his colleagues are working on the advocacy but stuck in the loop and no effective plan of action is taken. His last point was that if students want funding, they must show how they can use this money and yield results.

GAUBE questions about HICKS movement or what has he done so far? HICKS mentioned that he has not made any progress and said this is game of advocacy.

ROBERTS asked how big the part of funding is coming from Research assistantship and these research assistantships are less transparent and most of the time these jobs are like under the table. HICKS said TA

are unionized and there is a proper framework is in place but in the case of RA a lot of these funds are stipends and grants. HICKS said that he found the holes are loops in the policy where supervisor can withhold funds such practises are under review within the UVic supervision policy. HICKS said we do not want students coming with misunderstandings.

GAUBE said that Harvey is taking on the role within stem fundings for RA. And getting more transparency how the students are funded.
