***NOTE: A driving record can be obtained electronically and free of charge from ICBC. If you have moved from out of province or country, you will be required to obtain a safe driving record from your previous place of residence.*

Membership Benefits Include:

- Access 24 hours/day 7 days/week to any of the vehicles in the Modo fleet in: Greater Victoria area, including 2 vehicles at UVic (near Security and in the Family Student Housing complex); Metro Vancouver; Nanaimo; Squamish; and Kelowna
- Access to vehicles within Modo's roaming agreements with other carsharing organizations (various cities in BC, Canada, USA, Australia, and Mexico City).
