REPORTS AND OPEN DIALOGUE

CHAIR'S REMARKS 5:13

MADDOX will update GRC on the goings on of the Executive Board regarding annual plan completion and forwarded to Petri.

MADDOX said advocacy at GSS is expanding and more resources we are adding as much as possible furthermore MADDOX stressed about graduate students should have the ability to participate in activities other than academics

MADDOX advised the current GRC reps to encourage their peers to participate in the GRC.

A. GRC COMMITTEE, ELECTORAL OFFICER REPORTS, UPCOMING MEETINGS AND EVENTS 5:18

- Advocacy and Campaigns: WEBB mentioned that our work is slow during the summer and most of the work during the summer was the opportunity to work in the community garden and the committee agenda revolves around climate change. Furthermore, WEBB added that committee is trying to make the campus more lactation friendly. WEBB added that the committee would like to discuss with UVIC the responsible investment and graduate student should have a permanent position on it. WEBB said the deficit the UVic was running in relations to the people park. WEBB said that UVic replied to the enrollment contingency funds are used for paying for security on campus.
- Appeals: FIELDER said has been active and on top of regular appeals the committee worked on the TOR which includes the long-term concerns. FIELDER said that a disabled student requested to opt out once for the entire program time rather than opting out each semester. FIELDER mentioned that Appeals decided not to proceed with multi year opt-out for the UPASS which will add more complexity and privacy issues.

- Bylaw & Policy: MADDOX said committee completed TOR for electoral appeals committees. The TOR is more in aligned with the bylaws.
- Events: LAWTON mentioned that LAUREN walked some students to library to go through 3D printing. Further LAWTON added that most of the work is being preparing for the orientation event in the September and hence next month will be busier than rest.
- Finance: FIELDER said that the committee has been slow during the summer and the committee
 is preparing for the budget and audit for the GSS. The committee is looking into fund structure
 and improve backend flow and budgeting responsibly.

- Electoral Officer: QUALTER said there was a referendum and mentioned about the option based on annual increase rather than after 3 years.

Students discussed about ATRS and closure of McKinnon pool

ROBERTS said the CARSA repayment for UVic debt seems to be hidden in ATRS.

QUALTER said that all universities in Canada are built under similar contract

ROBERTS said that CARSA does not have enough capacity for all the students

QUALTER asked, if UVic aligns with other universities in Canada then would UVic change the ATRS fee name to CARSA debt repayment fees? MADDOX agreed by saying the ATRS fee is being used for CARSA debt repayment.

ROBERTS said after looking at the budget and noticed UVic having a contingency funds but is not being used to pay towards CARSA debt repayment and rather paid for hiring private security. ROBERTS said that the cost to rebuild quadra community pool is costing way too much and its still being rebuild as compared to UVic McKinnon pool being closed for a small amount for maintenance. MADDOX said he and chair of UVSS along with Faculty member to work towards closure of McKinnon pool issue. WEBB said that UVic is not using clear language when it comes to the rational for closure of the pool.

MADDOX said the students working at the pool will lose those jobs and students might not be able to receive the similar wage what they are earning now.

ROBERTS exerted how much swimming is crucial for community health, UVic swimming and kayaking clubs need the swimming pool access so that student feel safe, the clubs also store their equipment at the pool.

MADDOX said this will be a huge advocacy and campaign in the upcoming GRC term 2024-25.
