#### 2. JULY-AUGUST BOARD RECAP FOR KYLA

WEBB noted that the July GRC was well attended and the discussions were in-depth. Key issues for members were the McKinnon Pool closure and the trespass notice and breakdown of People's Park.

MADDOX received emails from members about how to get involved, and he promoted GRC as well as direct engagement with UVic from our members to amplify our voices.

WEBB noted that GRC reps liked hosting guest speakers as long as they were willing to engage in discussion.

PALAPARTY met with Dawn Schell from SWC about accessing a gender dysphoria diagnosis for gender affirming care as part of our insurance. PALAPARTY has also bene meeting with Trans grad students who may or may not have a formal diagnosis of gender dysphoria about how to access care. PALAPARTY recommended having a section on our website with step by step instructions for accessing gender affirming care.

GSAW planning is going well (thanks LAWTON and WEBB)! And funding has been secured for a single year. Petri from the staff team is working on socials posted. FGS Dean Robin Hicks is planning the supervision panel. WEBB would like to confer with TURNER about recruiting grad student panelists. The Library has given funding for prizes and is very excited to get involved.

MADDOX gave a review of the second incident of hatecrime and vandalism at the Multifaith Centre.

TASK: TURNER to check in with Jim Dunsdon, AVP Student Affairs, about the incidents at the Multifaith Centre.

FIELDER noted that the annual plan has been finalized and will be approved at the next board meeting.

FIELDER also recapped his and Irfan's work on GRC training plans and template for communication. MADDOX recommended recording meetings and posting the videos of the training.

Dear University of Victoria Graduate Students' Society,

## New registration requirements for third party sponsors

Since University of Victoria Graduate Students' Society is currently a registered third party sponsor under the *Election Act*, this letter is to inform you that a new Third Party Sponsor Regulation was deposited on May 16, 2024, which establishes new reporting and registration requirements for third party sponsors.

Third party sponsor organizations must now include as part of their registration information:

- the residential address of each principal officer (or principal member),
- a telephone number and email address where each principal officer (or member) can be contacted, and
- an email address where the sponsor can be contacted, if this information has not previously been provided.

This additional contact information will enable Elections BC to communicate important information to sponsors and their principal officers (or members), and to assist with assessing the independence criteria established by s. 239 of the *Election Act*. Principal officers (or members) can request that their personal contact information be redacted from public inspection.

In order to update the third party sponsor register, University of Victoria Graduate Students' Society will need to file a registration update using the attached <u>Form 422: Third Party Sponsor Registration</u>.

If University of Victoria Graduate Students' Society does not intend to conduct election advertising in relation to the 2024 Provincial General Election, you may wish to consider voluntarily deregistering by submitting Form 431: Third Party Sponsor Deregistration. Deregistering will remove you from the list of registered sponsors so that you do not receive further correspondence from Elections BC. An organization that voluntarily deregisters can apply to reregister at any time if, in the future, they wish to sponsor election advertising.

Please submit your registration update or deregistration form to our office by **July 23, 2024.** If we do not hear from you by this date, we will reach out to you again.

**Subject:** UVSS Food Bank

Hoping your inbox is not too overwhelming after being away!

I believe you met Laila but just in case thought I would e-introduce you! With our ED position currently left vacant we have split up some of the responsibilities and Laila among other things is also overseeing the Foodbank. As mentioned, two years ago the UVSS operational Reserve Fund needed to contribute just over \$200,000 to offset the needed purchases to support the growing student need and last year we were able to reduce this to \$100,000 in large part due to on-going regular donations through the university.

The UVSS is no longer able to support additional finances and will need to streamline our orders to meet the fees collected. To start we are also going to ensure only current students have access to the foodbank as it was more of an honor system previously. Students do still register for a pick-up a week or so in advance which will allow us the opportunity to verify the student numbers provided when registering (and they will have to show the same card with picture ID when the pick-up). We can verify undergraduate students but not graduate students so would like to discuss with you how to verify these as efficiently as possible (potentially us giving you the list or you confirming with systems that we can also have access to your list for this purpose)?

We will also need to look at the total amount of fees provided to the foodbank depending on if they are a graduate student or undergraduate and likely limiting access depending on what type of student they are (Eg Graduate students perhaps can only visit once per month vs once per week since the total contribution of fees from all graduate students since so much fewer of them compared to graduate students).

Please let us know if you have any immediate thoughts regarding student number verification and when would be a good time to meet later in August.
