REPORTS AND OPEN DIALOGUE

CHAIR'S REMARKS 5:13

WEBB to update on the goings on of the Board.

WEBB reported that the Board is still working on Annual Planning, which will be presented to GRC in the Fall. The Board also had their first meeting with UVic executive, where they discussed harm reduction work on campus in the last year, government relations and joint advocacy work to the Provincial and Federal governments, and got an update on the UVic budget. The board also had naloxone training, including information on the toxic drug crisis and harm reduction efforts on campus, jointly with the UVSS board.

GRC COMMITTEE, ELECTORAL OFFICER REPORTS, UPCOMING MEETINGS AND EVENTS 5:18

 Advocacy and Campaigns: MARRAGUT ARNAL noted that A&C is working on circulating free/low-cost recreation events and activities at CARSA via GSS communications channels; recommending a hike out of town for the ParticipACTION Grant that CARSA has; investigating whether there will be a Crystal Pool replacement committee; investigating what information TAs get access to from CAL and what training is available for providing accessibly education through LTSI.

- Appeals: LAWTON noted that Appeals Committee heard and adjudicated one appeal.
- Bylaw & Policy: WEBB reported that BPC has been working on bylaw amendments, which we
 will send to the AGM tonight, as well as a clean-up our of governance/policy manual. They
 have also reviewed a new primer for the Electoral Officer developed by TANVEER.
- Events: NOUREEN reported on the success of the Pride Maker Market last week and the Eid potluck. She invited people to get tickets for the bird feeder workshop tomorrow. In July, the Events Committee is planning on hosting another BYO book club and paint and planting event due to the success for the first events of these types. Also coming up in July are music bingo, a patio crawl, beach sports/games day, and a movie night.
- Finance: LAWTON noted that Finance Committee had a slower meeting: the annual audit is underway and being overseen by staff. We are awaiting information from the Constituency Groups to assist the Finance Committee in planning a Spring 2026 fee referendum.
- Stipend Review: JAMIESON-BURNS reported SRC reviewed and approved all May board reports.
- Electoral Officer: No report.

Better TA orientations and information sharing about these existing resources are not well known and understood around campus. TURNER noted that we can seek more information to circulate to our members.

1. GRC SEAT LIST FOR 2025-26 6:00

In September, GRC will have the ability to create additional seats on GRC for graduate level programs. TURNER recommends creating seats for French and Greek and Roman Studies, as these former departments (now part of SLLC) are highly active in GRC. The other departments within SLLC (Hispanic and Italian Studies and Germanic and Slavic Studies) have not placed a rep of GRC since at least 2020. Are there other programs not included on this list that the 2024-25 GRC recommends the 2025-26 GRC create seats for?

No recommendations, however Greek and Roman Studies needs to be added to the list as it is not part of the School of Languages, Literature and Culture (SLLC).

2. BYLAW AMENDMENTS 6:10

Bylaw 14.b.ii – pronouns update

 - i. Has a right of access at all times to all documents and records of the Society; and
 - ii. May require from the Executive Board, members, and staff of the Society such information and explanations as are necessary to enable him/her to report as required by the Societies Act, SBC 2015, c. 18.

ii. May require from the Executive Board, members, and staff of the Society such information and explanations as are necessary to enable them to report as required by the Societies Act, SBC 2015, c. 18.

Bylaw 15 - non-partisanship

Proposed language:

15.1 Non-Partisan Status

The Society is a non-partisan organization. For the purpose of this Bylaw, *non-partisan* means that the Society operates independently of any political party or candidate and does not endorse, support, or oppose political parties or candidates. The Society may work with elected officials, regardless of political affiliation, to bring the needs and interests of graduate students to the forefront of both elected representatives' and the public's attention.

15.2 Political Nature of the Society

Non-partisanship is not equivalent to being apolitical. The work of the Society is inherently political, as it involves advocating for the interests, rights, and welfare of its members to governmental bodies, elected officials, and other decision-making authorities. Decisions made by governments at all levels directly impact the lives of graduate students, necessitating active and informed advocacy.

15.3 Lobbying and Political Engagement

Pursuant to the *British Columbia Lobbyists Transparency Act*, all elected members of the Society's Executive Board are required to register as lobbyists with the provincial government. As political actors representing an inherently political organization, the Society and its Executive Board agree to abide by the following principles:

15.3.1 Policy-Driven Advocacy

The Society and its Executive Board shall assess, advocate for, and advance public policies based solely on the merits of the policies and their alignment with the interests and welfare of the Society's members, without endorsement of or consideration of any political party affiliation or connection to any candidate for public office.

15.3.2 Good Faith Engagement

The Society and its Executive Board shall advocate, in good faith, for its members and their interests to all relevant political parties and candidates at all levels of government, without partisan bias or preference.

15.3.3 Member Education

The Society and its Executive Board shall educate its members on public policies, laws, and other political matters impacting them to the best of their ability in an impartial, accessible, and factual manner, without promoting or opposing any political party, partisan organization, or candidate for public office. The Society may register provincially or federally as a third-party sponsor.

15.3.4 Democratic Participation

The Society and its Executive Board shall promote and facilitate graduate student engagement in the democratic process, including spreading awareness of voting rights and encouraging active participation in municipal, provincial, and federal elections, without political bias or favour towards any political party or candidate.

15.3.5 Prohibition on Endorsements

Elected members of the Society's Executive Board must not, as representatives of the Society, endorse, publicly support or oppose any political party, candidate for public office, or partisan organization.

15.3.6 Prohibition on Candidacy

No elected member of the Society's Executive Board shall seek nomination for, or become a candidate in, any municipal, provincial, or federal election during their term of office with the Society.

15.3.7 Platform Access and Engagement

While the Society may engage with political parties, candidates, or representatives from different levels of government (municipal, provincial, federal) where it serves the interests of its members, non-partisanship does not oblige the Society to offer equal platform or access to all political parties, candidates, or representatives. The Society retains the discretion to determine the appropriateness, relevance, and alignment of such engagements with its advocacy priorities and the welfare of its members. The Society is not required to provide equal opportunity or access for every political party or candidate.

15.3.8 Prohibition on Political Funding

The Society shall not accept, either directly or indirectly, any financial contributions, goods, services, sponsorships, or other forms of material support, including in-kind contributions, from any political party, candidate for public office, or related organization. For the purpose of this Bylaw, *indirectly* includes all potential indirect contributions, such as through third parties.
