1. WELCOME TO GRC! 5:15

Reference: Introduction of the GSS Board. WEBB empathised the crucial role GRC member play in students' life on campus.

2. HOW TO BE AN EFFECTIVE GRC REP! 5:20

Lead: TURNER

Reference: TURNER provided an overview of the first three meetings. Feedback from previous years indicated that GRC members were mostly interested in understanding what a GRC member does. TURNER noted that since meetings are limited to two hours, the content must be divided into three separate sessions.

In October, the GRC will receive a welcome from the Faculty of Graduate Studies. TURNER highlighted the importance of territorial acknowledgment. TURNER also explained the role of the GSS, its structure, and the duties of the committee. They emphasized that the GSS is a separate

entity from UVic, particularly in its advocacy work. The GSS is a non-profit society that provides space for students and operates under the Societies Act of BC. TURNER further elaborated on the organizational structure.

TURNER mentioned that the GSS regularly connects with UVic officials. They also addressed GRC attendance expectations and clarified to VELA that co-reps may attend periodically.

Board members presented their respective GSS committees and described the potential work involved. TURNER and the board shared tips and tricks with council members, and TURNER provided further explanation about GRC committees.

TURNER also emphasized that GRC members play an important role in holding the GSS Board accountable for its work.

WEBB gave a demonstration of MS teams to the Council members.

GRAD STUDENT APPRECIATION WEEK - JOINT PROJECT WITH FGS 5:55

3. GRC DEPARTMENT 6:05

Background information: The GRC includes a seat for every UVic-recognized Academic Unit (Department, School, or Faculty depending on the unit. E.g. Department of Chemistry, School of Earth and Ocean Sciences, Faculty of Business), as well as a representative from CUPE 4163. GRC has the right to create additional seats for a single academic year.

In 2024, UVic combined four departments into a single mega-department. The Departments of French, Germanic and Slavic Studies, Hispanic and Italian Studies, and Linguistics became the School of Languages, Linguistics and Cultures (SLLC). When the merger happened, GRC lost 3 seats. We've historically had very strong representation from French and Linguistics (though the last time we had Germanic and Slavic Studies or Hispanic and Italian Studies reps was in 2018). In order to maintain strong representation from these productive departments, GRC voted to create additional seats for each former department in 2024-25. We did not fill the Germanic and Slavic Studies or Hispanic and Italian Studies seats. French and Linguistics remained heavy hitters for GRC involvement. Based on this, we're recommending the following motion:

REPORTS FROM GRAD REPS ON UVIC COMMITTEES 6:45

Open Floor to hear any reports from graduate student representatives on:

- Board of Governors:
- Senate: DROZDETCKII, learning teaching and The Senate is considering exam accommodations for students with disabilities, focusing on the concept of Universal Extended Time (UET). Key questions include whether UET is effective, appropriate, fair, and equitable. To explore this, a working group will be established that incorporates perspectives from educational psychology, legal experts, implementation staff, instructors, graduate and undergraduate students, as well as Student Services for Disabilities (SSD) and the Centre for Accessible Learning (CAL). The discussion also noted that 26% of students with disabilities do not request formal accommodations, raising concerns about accessibility and equity. Additionally, the group will examine whether standard 50-minute classes are sufficient when extra time is needed.
- Faculty of Graduate Studies Council: ROBERTS Uvic is revising the language with research
 assistant academic where students get stipend and clarify that Uvic introduce RA

Dean of humanities Appointment Committee

The committee has finalized the Dean of Humanities position criteria, which was revised from the last time an appointment committee was convened 5 years ago. Should the incumbent, Annalee Lepp, wish to put herself up as candidate in consideration of the revised criteria, the committee will communicate this to the University community. The committee will continue to update on the appointment procedure as necessary.

Faculty of Graduate Studies.

The University is moving to a dual classification model for research assistantships, distinguishing between RA (academic) and RA (employment). RA (academic) involves work typically with the student's

supervisor, linked to academic goals such as dissertation research, and is paid as a stipend; this is not treated like an employer/employee relationship. RA (employment) is waged or hourly, with set duties and an employer-employee framework, not necessarily tied to the student's program, and the payment is through payroll, not necessarily a stipend/grant. UVic is looking to update funding offers, handbooks, and calendars so that this distinction is clarified.
